5 Treasurer's Report

Neil reported that we have ca £5,500 in the bank with ca £2,500 to be paid out, and some monies still owing. BG Membership Fees are changing – increasing for Grade D and above. Tony suggested that Cangaroos absorb the increase as at present there is only 4 members who will be affected by the increase. BG Non-Competitive Membership is decreasing.

5a Coaches Report

Tony gave his report.

There was some discussion around why members are not competing; if non-competing members should be training with Tony and Laura; and if those who are competing should be given extra training time. It was noted that Cangaroos is limited by the number of coaches and thereby the number of sessions we can run. Neil proposed that we limit the number of members per bed to 4. We would need to run 3 sessions on a Saturday if we do that.

As a club we aim to encourage the members to go through the Awards scheme as that helps with learning the competition moves.



It was agreed to focus on fewer competitions this year, with Coaches focussing on bringing members through the Awards system and into competing.
